8:10 pm: Second patrol of property and office trailers.

10:00 pm: Third patrol of property and office trailers.

12:10 am: Forth patrol of property and office trailers.

1:15 am: Alarm south property area out back - Found transient near trash dumpster. When I shine light on him he walks quickly across property, a second transient then comes out from porta-potti, and they both exit to the west on Jennifer Street. One of the transients had a large backpack. Both were ages 18-20 years.

Lid from spray paint can found near south side of building. Was not there on 12:10 round.

2:00 am: Fifth patrol of property and office trailers.

2:20 am: Return to base - Checked all storage containers on property – All secure. Checked all doors and windows on building and portable office trailers – All secure. Checked all tractors, storage containers and equipment – All secure. No sign of trespassers, vandalism or theft.

3:22 am: Securitas on site.

4:03 am: Alarm south side of office trailers – Found transient standing near bobcat which he was leaning on and looking inside. When he sees me he runs north toward SE Jennifer Street and disappears. Nothing seems to be amiss on bobcat and everything appears to be secure.

I will suggest to site supervisor tomorrow that Construction Company park bobcat 8 to 10 feet to the west so it is within view of North East CCTV camera.

4:30 am: Sixth patrol of property and office trailers.

5:00 am: Return to base - Checked all storage containers on property – All secure. Checked all doors and windows on building and portable office trailers – All secure. Checked all tractors, storage containers and equipment – All secure. Unlock both south and east access doors as per site superintendent. No sign of trespassers, vandalism or theft.
